**APPOINT DEAN KAZINCI AS TOWNSHIP MANAGER AND FIXING
THE SALARY THEREFOR AND DESIGNATING SIGNATORIES**

WHEREAS, the Township of Teaneck operates under a form of government known as the "Council-Manager Plan" (*N.J.S.A.69A-81 et seq.*), under which the municipality is governed by an elected Council and by an appointed Municipal Manager who serves as the Chief Executive Officer of the Township; and

WHEREAS, William Broughton tendered his resignation as Township Manager, effective April 30, 2019; and

WHEREAS, William Broughton's last official day of work at the Township performing the day-to-day responsibility of Township Manager was October 15, 2018; and

WHEREAS, as a result of the aforesaid resignation, Dean Kazinci was appointed Interim Municipal Manager effective October 15, 2018; and

WHEREAS, the Township Council is desirous of appointing Dean Kazinci as Township Manager effective May 1, 2019; and

NOW, THEREFORE, BE IT RESOLVED by the Township Council of the Township of Teaneck, Bergen County, New Jersey, that Dean Kazinci be and he is hereby appointed as the Municipal Manager of the Township of Teaneck, effective May 1, 2019, pursuant to *N.J.S.A. 40:69A-89*, with all the powers and duties conferred by the Council-Manager Plan of the Optional Municipal Charter Law, *N.J.S.A. 40:69A-81 et seq.*, and the Administrative Code of the Township of Teaneck; and

BE IT FURTHER RESOLVED that effective May 1, 2019, the salary to be paid to Dean Kazinci as Township Manager shall be \$175,000.00 per annum, pro rated as of May 1, 2019; and

BE IT FURTHER RESOLVED that Dean Kazinci's appointments as Interim Township Manager and Temporary Chief Financial Officer are hereby terminated effective May 1, 2019; and

BE IT FURTHER RESOLVED, that effective May 1, 2019, Dean Kazinci, as Township Manager and Issa A. Abbasi, as Chief Financial Officer, are hereby designated as signatories to the accounts maintained by the Township of Teaneck and are hereby authorized to sign on behalf of the Township of Teaneck any and all checks, notes or other financial instruments of the Township of Teaneck.
