1. How does Zero-Tax increase work now and what would you propose if elected?

I am in favor of expanding to other commercial areas because this can be a very lucrative opportunity for the Township of Teaneck. Going slow and carefully is key in my opinion. People think cannabis, they think retail shops. The reality is, that is only one type of license, There are several other licenses including packing cannabis gummies etc. That doesn't have to be on first floor retail or prominently displayed. So I do feel that as years go one, cannabis will be more of the norm and I don't want to see Teaneck miss out on the additional revenue.

8. As our population increases so does the need for adequate parking and traffic concerns. How do you plan to address these needs for our residents and merchants?

I am a proponent for adding more parking. I created a parking fund that every developer in Teaneck has to pay into so that Teaneck can start building up a piggy bank to help increase and enhance our parking infrastructure. In the recent proposed development with Stop & Shop I required the developer to double the parking spots proposed for Cedar Lane shoppers, not only to help support the current businesses but better planning for the future.
