1. What is the role of a town council member? Why are you running for Teaneck council?

3. Tell us about a time where you worked through a challenge with a team of people who did not agree on the best solution. How did you navigate conflicting views? How did you resolve the challenge?

A time I worked through a challenge involving conflicting views was during my years as a Girl Scout leader. We were deciding how to divide the proceeds from the cookie sales, which would be used to fund a camping trip. Some parents and scouts felt that the funds should be divided based on how much each girl sold, rewarding the highest sellers. Others believed that the proceeds should be split equally among all the girls, regardless of individual sales.

To navigate this, I led a discussion with the scouts and parents, emphasizing that Girl Scouts is about teamwork and shared experiences. I reminded them that while some girls may have sold more cookies, everyone had contributed in their own way, whether through promotion, attending booths, or helping with other troop activities.

To resolve the situation, I proposed a balanced solution: we would split the majority of the proceeds equally, but set aside a small portion as individual recognition for the top sellers in the form of special badges or small prizes. This allowed us to acknowledge the efforts of the highest sellers without creating division within the troop.

Ultimately, we agreed on this approach, and it strengthened our sense of unity as we all went camping together, funded by everyone's contributions. This experience taught me how to listen to all sides, foster collaboration, and find solutions that prioritize fairness and group cohesion.

Incorporating technology for remote participation can make our meetings more inclusive, ensuring that all residents, especially seniors and those with disabilities, can engage in council discussions. Together, these initiatives will foster a more participatory and responsive local government.
